

APPLICATION for MEMBERSHIP

The undersigned hereby applies for membership in THE HOUSTONIAN, a club owned and operated by Houstonian Campus, Ltd. (a Texas Limited Partnership). Prior to acceptance for membership, references to the undersigned will be as "Applicant", and after acceptance of membership, references to the undersigned will be as "Member". Both Houstonian Campus, Ltd. and the club facilities known as "THE HOUSTONIAN" and located at 111 North Post Oak Lane, Houston, Texas are referred to herein as "Club". As provided below, when accepted by Club Management, this application and the other matters referred to shall constitute the Membership Contract between Member and Club. In support of this application and as a part of the Membership Contract, the parties agree as follows:

1. Member agrees to pay the Club a non-refundable fee ("Initiation Fee") for initiation of Membership privileges at the Club. The parties agree that the Initiation Fee is a one time charge, is non-refundable under all circumstances, and is not a charge in prepayment of services to be rendered or for facilities to be provided by Club.

Member further agrees to pay Club a monthly sum as a Membership Fee for so long as Member maintains Membership in active status. The amount of such monthly Membership Fee may be adjusted from time to time by Club as provided by its Bylaws, policies, and procedures. That monthly Membership Fee, which may vary with the type Membership involved, is the basic charge to be paid for the services rendered and facilities furnished by Club to Member. Member also agrees to pay any incidental charges incurred at the Club for such separately priced goods and services as food, beverage, massages, etc. Member shall be responsible for all applicable sales tax payable with respect to the Initiation Fee, the Membership Fee and any other charges incurred by Member at the Club.

2. This Membership Contract is terminable at will by Member on 30 days prior written notice to the Director of Membership Services, at the address hereinafter set forth. Member shall be responsible for any unpaid Membership Fees and incidental charges through the effective date of such termination.

3. This Membership Contract does not confer upon or vest in Member any legal or equitable ownership in the property or assets of the Club.

4. Prior to engaging in vigorous exercise at the Club, Member is encouraged to obtain a physician's approval to exercise or undergo a cardiovascular stress test.

5. Club has filed a registration statement with the Texas Department of Labor and Standards. A copy of such statement is maintained at the Club and any member or prospective member may inspect such statement. A comprehensive list of membership plans offered for sale by Club is also maintained at the Club and is available for inspection by any member or prospective member.

6. If this Membership Contract is designated as a Corporate Membership, then the membership shall be maintained in the name of a corporation or other business entity (the "Company") pursuant to the Bylaws, policies and procedures, and the rights and privileges under the membership shall be assigned to one particular designated bona fide owner, employee, or officer of the Company, subject to the approval of the Club. The Company and the individual designee shall be jointly and severally liable for all dues and other charges incurred in the name of the Corporate Membership. If the designee with respect to a Corporate Membership ceases to be a bona fide owner, employee or officer of the Company, then the Company must notify the Club of such cessation within ten (10) days after its occurrence. Subject to the Bylaws, policies and procedures, the membership may then be transferred to a new individual designee.

7. The Membership Contract consists of this application, when accepted by the Director of Membership Services on behalf of the Club, and the Bylaws, policies, and procedures of the Club, as the same shall be amended from time to time, at the sole discretion of the Club, which Bylaws, policies, and procedures are incorporated herein by this reference and made a part hereof. If payment of the Initiation Fee is to be made by Member on an installment basis, the Membership Contract shall also include the Retail Installment Contract setting forth the terms of such payment, which additional document is also incorporated herein by this reference and made a part hereof. The Membership Contract shall be the exclusive terms of the agreement between Member and Club, and Member acknowledges receipt of a copy of the current Bylaws, policies, and procedures of the Club.

The Member agrees that all disputes and controversies that may arise between the Member and the Club, including but not limited to any dispute or controversy regarding, arising out of, or related to Club operations, management, or facilities, or to membership rights or privileges, shall be determined in Harris County, Texas by arbitration under the Commercial Arbitration Rules of the American Arbitration Association, and shall be governed by the laws of the State of Texas. Notice of demand shall be filed in writing with the other party to this Membership Contract and with the American Arbitration Association. A demand for arbitration shall be made within two (2) years after the dispute has arisen, but in no event shall a demand for arbitration be made after the expiration of the statute of limitations applicable to the dispute in question. The ruling of the arbitrator(s) shall be final, and judgement upon this award rendered by the arbitrator(s) may be entered by any court having jurisdiction thereof. This agreement to arbitrate is specifically enforceable.

Applicant acknowledges that membership rights and privileges applied for, and Club operations, benefits, facilities, Rules and Regulations, and Bylaws may be changed in the future by Houstonian Campus, Ltd. (a Texas Limited Partnership) at its sole discretion. If accepted for membership, Member agrees to accept and be bound by such changes.
